Class placement is based on your child's age on September 1st, 2025.

Financial Agreement

- 1. Registration is \$150 for the first child and \$125 for each additional sibling. This fee is non-refundable.
- 2. A supply & curriculum fee per child is due by June 9th, 2025. This will hold your child's place for the upcoming school year. Failure to pay in June may result in loss of space.
 - 2-day classes are \$125
 - 3-day classes are \$150
 - 4-day classes are \$200
- 3. The yearly tuition is paid in 9 equal installments. (September-May)
 - 2-day classes are \$270/month
 - 3-day classes are \$320/month
 - 4-day Pre K classes are \$385/month
 - 4-day Bridge classes are \$415/month
- 4. The tuition for the month of May 2026 is due August 1st, 2025. Tuition will be collected September-April during the school year. Failure to pay may result in loss of space. The tuition is non-refundable.
- 5. Tuition is due on the first of each month and will be considered late after the 10th of the month. After the 15th, parents will be directed to the Director to pay their outstanding balance before their child will be admitted to class. (This includes May tuition which is due in August.)
- 6. Two weeks' notice is required before a child withdraws from CDO in order to determine the amount of tuition reimbursement, if any.
- 7. If a child withdraws after March 1, 2026, refunds are not available.
- 8. Parents are encouraged to communicate with the Director regarding any unforeseen difficulty in meeting the financial obligation to CDO.
- 9. A child may be unenrolled from the school due to circumstances outlined in our Parent Handbook or actions deemed inappropriate by the Director, including behavioral problems and non-payment of tuition and fees.
